## Re: Application for Welfare Grant

Slovenian Schools Committee of N.S.W. was founded two years ago by Slovenian teachers and representatives of all Slovenian Organizations situated in Sydney.

Originally it was intended to be only an ad hoc organization to do the preparatory work for the recognition of the Slovenian language as a Higher School Certificate Subject. However, because it represented a united Slovenian effort and all Slovenian organizations joined in, it received a widespread support and became a representative body for matters relating to the welfare and education of Slovenian youth.

The Committee if composed of two delegates of each Slovenian Association, four in number, one delegate from each Slovenian Ethnic School and one from the Slovene Church Mission and all Slovenian Teachers individually.

The Management Committee is composed of the President, the Vice President, the Secretary and the Treasurer, but the entire Committee meets once a month.

At present the Committee is financed by the four Associations in the amount of \$150.00 per year each and by voluntary contributions from Associate Members and general Slovenian public.

The Committee is now seeking registration under the Charitable Collections Act, and a copy of the Constitution will be forwarded to you as soon as if becomes available.

The Committee is asking for the grant, so that it can employ two part-time Welfare Officers to visit all Slovenian families with children and to conduct interviews to ascertain the needs and requirements of Slovenian youth. Slovenians are a very scattered community, not concentrated in any locality, and the only way to obtain information and to provide proper advice and guidance is to visit families at home.

The money requested in this grant will be used to engage two Welfare Officers on part-time basis.
