

Disagreements in the committee of SDS in 1970/71 - led to the break away of 4 committee members (-) who aimed at starting an alternative club.

Records show that the breakaway group began to use name of SDS Pty Ltd - but were forced to stop when the committee of the original SDS registered its name and precluded the new club from using it.

Thus Triglav Pty Ltd was formed, comprising of a ~~set~~ set of directors and shareholders. Shares were sold at \$2.

Within months the organisation of Triglav Pty Ltd and its ~~legal~~ official set up had changed thus:

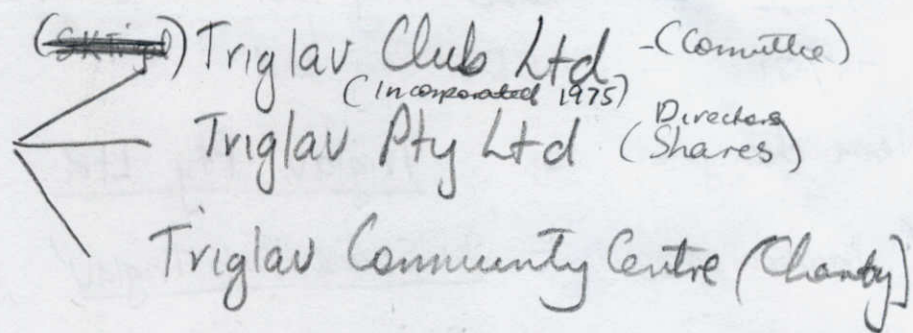

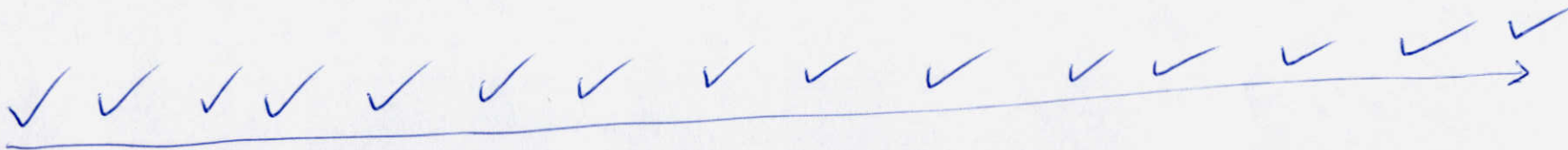

On 15th July, 1975 the Slovenian Club Triglav was incorporated as Triglav Club Ltd.

However, records cause some confusion, ~~because~~ when a decision to pursue incorporation was made at AGM of Triglav Pty Ltd on ~~8.2.75~~ 4. 11. 73¹, ^{some began to use T.C. Ltd.} the use of Triglav Club Ltd was later changed with 'Club Triglav' incorrectly.

* Triglav Community Centre paved the way for the erection of Cankar's Monument for 100th anniversary of his birth. This eventuated in Dec, 1976

* Opening of new club house - 10th & 11th Dec, 1982
