We refer to your telephone call with the writer of the 19th of October last and advise the writer attended at the New South Wales Treasury Department and interviewed the Officer-in-Charge of Poker Machines.

Prior to the Poker Machine Licence being granted, it is necessary to complete a Statutory Declaration in the Form enclosed herewith, containing the details set out therein.

In order to assist in the completion of this Form, we enclose herewith copy of booklet called "Licensing of Poker Machines in Registered Clubs" and your attention is drawn particularly to pages 6 and 7 thereof. In addition to the information contained in this booklet, the following information is supplied, as a result of the conference held with the Officer-in-Charge of Poker Machines.

The Club must be buying the machines either for cash or on terms approved by the Treasury, which said terms require a deposit of 10% of the balance payable over three years, the maximum period, and interest at normal commercial rates.

The machines, if second hand, and manufactured after 1979 have incorporated therein approved specifications. Those manufactured before 1979 cannot be used unless changes are made to bring the machines in line with the approved specifications.

Date 21 Oct. 1983

All machines must return a minimum of 85% to the player and none of the machines can be changed without application being made to the Treasury.

In the event of the machines being installed in the Club premises between now and the 31st of December 1983, a licence tax rate, as set out on page 14 of the booklet applies. In the event of the machines being installed after the 1st of January 1984 then half the rates apply.

Your attention is also drawn to the last paragraph on page 14 that if the Club has a membership of less than 250 and as we understand it has, then the Club is entitled to a concession of only half the normal licence tax.

As suggested by the Treasury, that prior to operating the machines, an appointment be made by two Club Representatives to see the Inspectors at the Inspector Section of the New South Wales Treasury.

We also enclose Circular dated the 14th of July 1983, prepared by the Treasury relating to poker machines


