Hereunder please find a list of Notices of Motions received to be put to the Adjourned A.G.M. on Wednesday 2nd February 3pm at the Concordia Club.

1. Alterations to Competition Rules.

Rule 5. (a) (New Paragraph) An appeal against any decision handed down by the P & D Committee or Sub-Committee, having been made in writing as per Para. 2 above, shall be supported by a personal plea before the Committee if it be the wish of the Club lodging the appeal

Rule 5. (c) (New Paragraph) If, resulting from an enquiry or investigation, it is deemed prudent to lay charges against any Club or person then the charge must be intimated and the Club and/or person afforded ample opportunity to plead before the Committee in its or his defence.

Rule 5. (d) DELETE the last paragraph.

ADD ... Any Club having made an appeal against a P & D decision made in relation to the Club; and having had it rejected in part or as a whole shall have a final right of appeal to a Tribunal of five (5) comprising one Officer from each of five (5) Clubs within the Division in which the Club competes. The Tribunal shall be presided over by the P & D Chairman and shall be convened within fourteen (14) days of the appeal being lodged.

Rule 5 (g) ADD ... Providing such penalty is in keeping with accepted practice and policy; it does not contravene the League's Constitution or Competition Rules and abides by The Laws of the Game as interpreted by The International Board.

Rule 5 (h) (New Paragraph) During the hearing the accused person may be accompanied by a representative from his Club; Both will be present during cross-examination of the Referee and/or witnesses. Where two parties are involved, be they Clubs or Persons (e.g. Players both sent off for fighting; an abandoned game..) .. each shall be entitled to be present ..

(a) During interrogation by the Committee of the other Party or Witness.

(b) During interrogation by the Committee of the Referee. Questioning of those involved shall be permitted by all parties and in the presence of one another in support of their plea.

Rule 5. (i) ADD .. after the word 'representation, where it first appears, the words ... 'at the discretion of the Club'.

Rule 6. (g) Paragraph 1. Alter to read 'In the event of a match being terminated by the Referee before the completion of the time specified in the Rules; for any reason stated in Law 5 of the Game, it shall be either (1) Replayed in full - or - (2) The result at the time of the stoppage will stand. To reach its decision in the matter the Committee shall consider the amount of time played and to whom or what the abandonment is attributed. Additional penalties for any misdemeanour found proven shall be dealt with as per Rule 5 (g).

PENALTY POINTS SYSTEM. ADD to the Rules ... At least five (5) days Notice must be given to the Club of any Player automatically suspended for his one match by reason of having amassed 12 or more points.

POLICY. Referee appointments must be presented to The League Management Committee for approval prior to notification being given to the individual Referee; emergency changes excepted.

2. Addition to Explanation of All Age Competition

- Rule 4 New Paragraph to (e) Players eligible to play in Semi Finals and Finals of the Amateur Cup, Knock-Out Competitions or Round Robin Series must have played at least three (3) competition matches (either Premiership, Amateur Cup or Knock-Out) for his Club prior to the Semis and Finals of these Competitions.

3. Alteration to Explanation of All Age Competition

- Rule 4 (e) DELETE the words 'is not permitted'
ADD .. the words 'will be permitted'.

4. Rule 4 (c) That for the 1983 Season at the completion of the Premiership that the Top Four in each Grade shall then compete in a Round Robin Series.

5. Rule 1 Competition Rules That for the 1983 Season the Knock-Out Competition be deleted.

The closing date for the '83 Affiliation forms with \$25.00 deposit was 24.11.82 but owing to the theft of the League papers this has been brought forward to 2.2.83. Clubs with their '83 Affiliation form and \$25 deposit not in the hands of the Secretary on this date will not be accepted for the '83 Season. Late applications may appeal to the Management Committee.

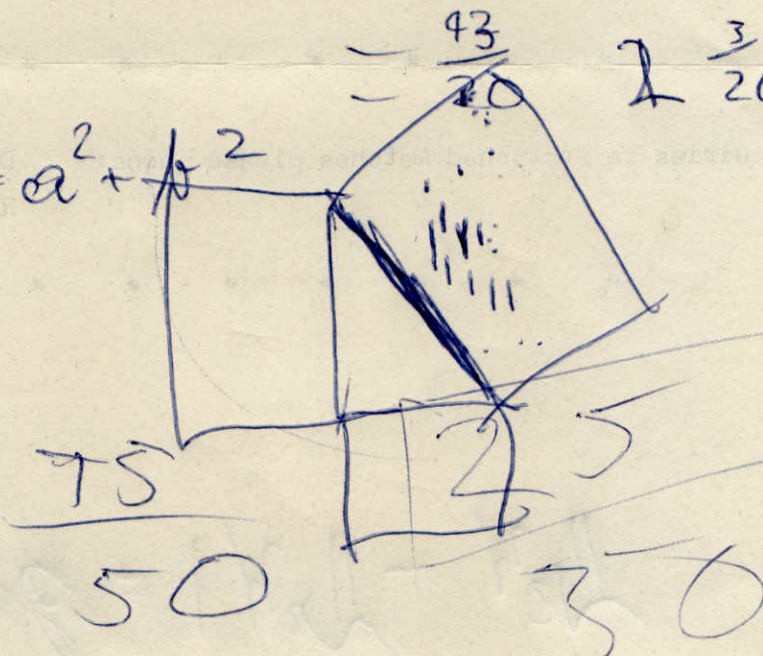

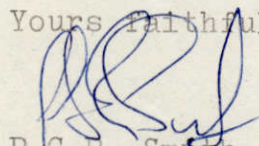
