Dear Friend,

Once again I am appealing to you as in my first letter on the 4th of October, 1984. May I resume in short:- It is about Slovenians in Australia, setting in motion the task of collecting monies with which they would purchase the apparatus for diagnostic of the worst forms of inherent and induced heart defects. This apparatus would be urgently needed by the University Pediatric Clinic in Ljubljana. The director of the clinic is professor Dr. Joze Jeras.

The most up-to-date diagnostic is based on Ultra-Sonic method, that shows the changes of diseases in various organs of children's bodies. The price of this type of apparatus is really high, 130,000 U.S.A. dollars. But, because this most advanced and for the diagnostic of heart and brain, child diseases most efficient, Hewlett Packard apparatus would be the first of its kind in Ljubljana, the firm gives 10% rebate on the price.

I have spoken with many representatives of our organisations and clubs, and many of them are prepared to support this humane action. I am turning to you with this plea, for your support and co-operation. Australians too shall be included in this effort in order to give this humane action a stronger, larger sway.

Kindly, let me know as soon as possible your opinion and willingness to lend yourself to this good work. I know that all clubs and organisations have plenty of their own worries, also monetary, but it is exactly through Sloven organisations in Australia, that this appeal can be successfully launched.

Spoštovani,

verjetno bo to moje današnje pismo malo nenavadno.
Moje ime je Eleonora Cigoj - poročena White. V Avstraliji sem že 36 let.
Letos sem bila na obisku v Sloveniji in ob tej priložnosti sem si ogledala tudi Univerzitetno pediatrično kliniko v Ljubljani. Direktor te klinike prof. dr. Jože Jeras me je tudi seznanil s problematiko klinike.

Ko sem videla otroške obraze v bolniških posteljah, se mi je omehčalo srce in obšla me je misel: Bi avstralski Slovenci lahko kaj pomagali tem otrokom v Sloveniji? Morda bi zmogli zbrati denar za aparat za diagnostiko najtežjih oblik bolezni otroškega obdobja. Ta aparat bi v Ljubljani nujno potrebovali.

Najsodobnejša diagnostika temelji na ultrazvočni metodi, ki omogoča prikaz bolezenskih sprememb na raznih organih otrokovega telesa. Še posebej velja to za prirojene in pridobljene hibe srca. Ta preiskavna metoda (ehokardiografija) je za bolnika povsem nenevarna in neboleča, v nasprotju z dosedanja diagnostiko srčnih bolezni (kateterizacija srca ipd.).

Cena tovrstnega aparata je zelo visoka in znaša okrog 130.000 ameriških dolarjev. Ker pa bi bil tovrstni najsodobnejši in za diagnostiko srčnih in možganskih bolezni pri otrocih najzmoglivejši aparat firme Hewlett Packard prvi v Jugoslaviji, daje ta firma 10% popust pri ceni.

Cena je resda visoka - toda tudi plemenitost slovenskih src je velika! Upam, da bi Slovenci ob tej plemeniti akciji po vsej Avstraliji lahko poslali naši Ljubljani najdragocenejše darilo, ki bo služilo zdravju naših rojakov doma.

Rada bi skupaj z Vami zastavila to akcijo, ki bi jo potem razširili po vseh slovenskih skupnostih. Seveda pa se moramo najprej nekje srečati. 3. oktobra sem bila prvič v Merrylandsu in sem se dogovorila s p. Valerijanom in p. Cirilom, da se lahko srečamo v dvorani slovenskega verskega središča v Merrylandsu in sicer bi to bilo v sredo, 7. novembra 1984 ob 7. zvečer. Vabim Vas, da pridete ta večer ali da Vaša organizacija koga delegira za to dobrodelno akcijo.

Zasmilili so se ji bolni malčki in vprašala se je, če bi mogla tudi ona, s pomočjo drugih Slovencev in njihovih prijateljev v Avstraliji, zbrati devize za kako dobro, svetovno znano zdravstveno napravo. Upravnik bolnišnice ji je povedal o ultrazvočni elektronski napravi, ki se z velikim uspehom uporablja v svetu in ki bi mogla izredno mnogo pomagati pri odkrivanju najtežjih bolezni na srcu in možganih. Ker ta naprava stane 130 000 ameriških dolarjev ni verjetno, da bi jo mogla bolnišnica kupiti v doglednem času. Ta elektronska naprava se imenuje ehokardiograf. Deluje s pomočjo nadzvočnih frekvenc in ni nevarna, v nasprotju z rentgenom, ki more biti nevaren s svojo radioaktivnostjo. S pomočjo ehokardiografa morejo zdravniki videti stanje srca in možganov, ne da bi morali nekomu odpreti prsni koš ali pa lobanjo. Gospa White zdaj obiskuje klube in navdušuje ljudi dobrega srca, da bi kaj prispevali.

DEAR MEMBERS AND FRIENDS,

To some of You this will be the first letter from our Slovenian Club. In search for families of Slovenian origin we came across Your name too. We intend to send You our Club's News Letter from time to time, except if You decide to let us positively know that You do not wish to keep in touch with the Slovenian Australian Association in Canberra. In such a case please return us this letter with the remark: "Not interested".

In this letter we are sending You extracts from documentation concerning Echocardiograph, which would be bought by Slovenians and their friends in Australia and donated to the Pediatric Clinic of Ljubljana Hospital in Slovenia.

Let me explain to You the whole story in a few words again. Mrs. Eleonora White, born Cigoj, is a woman of Slovenian origin, married to an Australian husband. While visiting Slovenia she visited Pediatric Clinic of famous Ljubljana Hospital. Seeing the sick youngsters she wondered if there would be something that she, with other fellow Slovenians and their friends in Australia could do for these unlucky kids. The Hospital Management told her about a new electronic diagnostic machine which is available in the world and which could do so much in diagnosing and detecting heart and brain illnesses from their very early stages on. The Echocardiograph, as the machine is called, works with ultrasound waves and is therefore not dangerous like X-Ray machines are. The Echocardiograph enables non invasive diagnosis, which means, doctors do not have to operate on a kid to establish the condition of his or her heart or brain. Because of the high cost (130 000 American dollars) it was not likely that the Ljubljana Hospital could afford to buy the machine soon yet. Mrs. White promised to do her best and so she is now organizing donations for the Echocardiograph amongst Australian Slovenians and anybody in Australia that would wish to participate.

In our Slovenian Club in Canberra for the action responsible persons are: Bert Pribac (823250), Franc Culek (514568), Lojze Kavas (976449) and Janez Cerne (315471). You may contact any of the above persons, or even better, You may donate money in our Slovenian Club at Phillip. Our barman will issue You with an official receipt. The money will stay under the supervision of our Club, under a special account and will be handed over to the Central Committee in Merrylands just before the appeal ends. There will be at all times kept full names, addresses and amounts of donations of all the contributors, so that in case we would fail to collect enough money, all the collected money will be promptly returned to the donors. It is estimated that collection for the Echocardiograph will last about 18 to 24 months. Certainly, the sooner the needed money will be collected, the sooner the Echocardiograph will be bought and the sooner kids in Slovenia and kids from other republics of Yugoslavia will be benefiting from it.

The Echocardiograph is first of such kind electronic machines in Yugoslavia. This is why Hewlett Packard, the American manufacturer is giving us 10 % discount. After demonstrating the greatness and capability of their machine in Ljubljana Hospital the Company expects that some other hospitals in Yugoslavia will get enthusiastic about equipping their hospitals with such a great and capable product of modern medical science.

We realize that the amount of money we are supposed to collect is huge. We will also understand You if You will decline this support because of Your overcommitments to some other causes or for any reason. Still, if You decide to donate towards Echocardiograph, many kids will get better sooner because of Your good heart and last but not least, God will not forget ever for what You have done to help another human beings in need. Thank you in the name of our Clubs Committee too!



Dear Mrs. White,

I met Prof. Jeras and two of my colleagues Dr Brus and Dr. Jaksa in the Paediatric Clinic in Ljubljana on Thursday 13th June, 1985. The main interest of Prof. Jeras is paediatric neurology, that of Dr. Brus paediatric diabetes and that of Dr. Jaksa paediatric nephrology. I also met other colleagues of mine both in Ljubljana and in other Slovenian country centres.

None of us has any doubt that HP 77020AC Echocardiograph is indeed most needed in the Clinic and that its purchase through the generosity of our country(wo)men in Australia would serve a most worthy cause.

Paediatric Clinic in Ljubljana is separated from the Clinical Centre by a distance of almost 1 Km. As there are no surgical facilities in the Paediatric Clinic, children have to be transported between the two places. There are at present no modern echocardiographic facilities in Slovenija and children have to be referred to another centre in Yugoslavia for this investigation.

Although my colleagues in the Paediatric Clinic in Ljubljana are working under very difficult conditions, I was very impressed with the quality of their work. If there is anything I can do to support your action in raising the money for the above equipment, please let me know. And if the generosity of our country(wo)men in Australia exceeds the price of the cardioechograph, there is further assistance needed to the Paediatric Clinic in Ljubljana.

INCOME TAX : OVERSEAS AID ORGANISATIONS

Reference is made to your recent telephone conversation with an officer of this office, regarding tax deductible donations to an overseas hospital. The organisation seeking recognition would be considered under the overseas aid provisions of the Income Tax Assessment Act.

The organisation, in the first instance, must be approved for the purposes of the scheme by the Minister for Foreign Affairs. Where an organisation has been so approved, gifts made to a public fund established by that organisation may qualify for deduction where the Treasurer is satisfied that the fund is established exclusively for the relief of persons in countries that have been certified by the Minister for Foreign Affairs as developing countries.

It is also expected that the fund conforms with the normal requirements that govern the eligibility of public funds to which the income tax gifts provisions apply. The requirements of such a fund are that -

- (a) the fund should be public in the sense that it is administered by a committee of persons having a degree of responsibility to the general community;
- (b) members of the general public should be invited to contribute;
- (c) gifts to the fund should be kept separate from any other funds of the sponsoring organisation (a separate bank account would be required) and clear accounting procedures evidencing this are necessary;
- (d) the fund should be governed by a constitution or set of rules from which it is clear that the exclusive purpose of the fund is to provide relief to persons in certified developing countries;
- (e) consistent with the requirements at (d), the constitution or rules should provide that on the winding up of the fund any surplus money is to be transferred to some other fund qualifying under the overseas aid gift provision of the law, i.e., sub-paragraph 78(1)(a)(lxii) of the Income Tax Assessment Act 1936; and
- (f) the name of the fund should preferably reflect the fact that it is the developing countries aid fund of the organisation concerned, and gifts to the fund should be receipted in that name.

Where the Treasurer is satisfied with the purpose for which the fund is established, he may at his discretion declare the fund, by notice published in the Commonwealth Government Gazette, to be an eligible fund for the purposes of the overseas aid gift deduction scheme. Generally, gifts to an eligible fund will be deductible from the date of the Gazette declaring its eligibility, although a later date may be specified for this purpose.

To obtain further information in relation to the requirements for admission to the overseas aid income tax gift deduction scheme you should contact the Australian Taxation Office, Canberra 2060.

I refer to your letter of 28 October 1985 seeking income tax deductions for donations made to your organisation for the abovenamed purpose.

Your request falls for consideration under the Overseas Aid Gift Deduction Scheme. An organisation seeking recognition under that Scheme must, in the first instance, be approved for such purposes by the Minister for Foreign Affairs. Where an organisation has been so approved, gifts made to a public fund established by that organisation may qualify for deduction where the Treasurer is satisfied that the fund is established exclusively for the relief of persons in countries which have been certified by the Minister for Foreign Affairs as developing countries.

I have therefore arranged for your application, on behalf of HELP, to be referred to the Australian Development Assistance Bureau at the Department of Foreign Affairs for submission to the Minister for Foreign Affairs.

Should the application be approved by the Minister it would then be necessary to submit to this Office, for subsequent referral to the Treasurer, documentation establishing the abovementioned public fund. Such a fund should comply with the normal requirements which govern the eligibility of a public fund under the income tax gift provisions.

The requirements of such a fund are that:

- (a) the fund should be governed by a constitution or set of rules from which it is clear that its exclusive purpose is to provide relief to persons in certified developing countries;
- (b) members of the general public should be invited to contribute;
- (c) gifts to the fund should be kept separate from any other funds of the sponsoring organisation

2.

(a separate bank account would be required) and clear accounting procedures evidencing this are necessary;

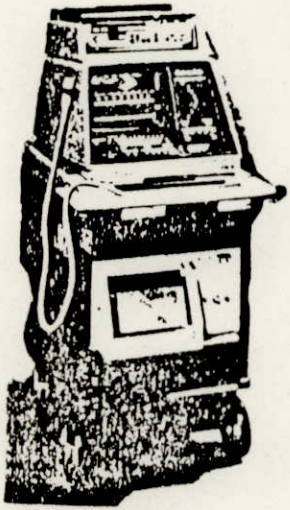
- (d) the fund should be public in the sense that it is administered by a committee of persons, a majority of whom have a degree of responsibility to the general community. In this respect it would be necessary to know details of the occupations and positions in the community of the fund's office-bearers;
- (e) consistent with the requirements at (a), the constitution or rules should provide that on the winding up of the fund any surplus money is to be transferred to some other fund qualifying under the overseas aid gift provision of the law, i.e. sub-paragraph 78(1)(a)(lxii) of the Income Tax Assessment Act 1936; and
- (f) the name of the fund should preferably reflect the fact that it is the developing countries aid fund of the organisation concerned, and gifts to the fund should be receipted in that name.

If the Treasurer is satisfied regarding the purpose for which the fund is established he may at his discretion declare the fund, by notice published in the Commonwealth Government Gazette, to be an eligible fund under the overseas aid gift deduction scheme. Generally, gifts to an eligible fund will be deductible from the date of the Gazette declaring its eligibility, although a later date may be specified for this purpose.

Any attempt to portray the role of Slovenes in the advancement of Australia from its colonial beginning encounters heavy emphasis on the exploits of Serbs and Croats whilst Slovenes are hidden under the pre-World War I label of Austrians, which is not surprising mindful of the then existing Austrian-Hungarian Empire.

To confirm this image, I need only to quote from an article on the life of Andrew Fisher (Australian Prime Minister 1910—15, vide *Canberra Times* 25. 1. 66).

Fisher had shown a resistance to anti-foreign sentiment at the Hobart Conference of the Labor Party in 1912. A resolution against Austrian (i. e. Slav and Italian) migration was proposed to the Conference. The record shows Fisher's view,

"Mr. Fisher said he could not support this motion. The Party was a Labor Party, but it was also a socialist party. Some Southern Europeans discovered parts of Australia and were doing more by their inventions in the present day than some of the Northern races. He therefore could not support the principle contained in the resolution and he would hesitate to stigmatize any class of people on account of their alleged lower moral code."

Dealing with the issue of their acceptance of lower rates of pay, he said, "If these people were being exploited by unscrupulous capitalists, it was the duty of the Government to protect them."

Fisher, of Scottish birth, had gone into the pits in his homeland as a teenager, subsequently migrating to Queensland when he was employed as a coal miner before entering politics at an early age.

In the conference issue mentioned, it was the W. A. branch that had adopted a posture of xenophobia to some non-British mine workers whom it could reasonably be assumed were of Slovene stock.



Kim Beazley, a senior Minister in the Whitlam Government and a keen political researcher of Western Australian political history, with the advantage of perusal of newspapers of that era, confirms this assessment. It is equally pleasing to know that in the face of the intervention of Prime Minister Fisher, the 1912 A. L. P. National Conference rejected the narrow minded Western Australian resolution.

Since this was the period of Australian history when the Government led by Fisher created the Commonwealth Bank to combat the monopoly of British Banks, established the Royal Australian Navy, making its command separate from the Royal Navy and constructing

the Trans-Continental Railway, it can be said this era of progress saw Slovenes with many other people from Europe developing Australia into a viable nation. I must confess, however, that the intervention of World War I with its divisive referendums on conscription for overseas army service and the harsh economic conditions of the Thirties all tended to blunt the new national spirit forged by Fisher and created a society very isolationist in its concepts of world events.

Such attitudes could, to a large degree, be attributed to an education system which saw history in State schools only dealing with British feats of arms in Europe and elsewhere whilst the Catholic schools, while rightly questioning the doctrine that British Governments were infallible in the diplomatic field, did no better in developing a history curriculum which explained the historical origins of the major European nations and empires.

To show the absurdity of this history "taught with blinkers", one has only to examine the various acts of censorship applied to fledgling ethnic newspapers because their interpretation of overseas events conflicted with the British Foreign Office.

Yugoslavian and progressive Italian elements all felt the weight of the Commonwealth Attorney-General on their backs whilst in contrast Mussolini/Hitler could be eulogised.

Slovene minorities in the Istria and Carinthian regions of Europe might as well have been in the deepest heart of the African continent as to expect their history to appear in the Australian press, much less Australian school history books.

When the Chifley post-War Labor Government under its energetic Immigration Minister, Arthur Calwell, introduced an imaginative immigration programme, it can well be understood how barren was the average Australian's concept of the newcomers' political heritage and when we considered the ratio of Slovenes to Croats and Serb, the efforts of the former to educate his Australian workmates was a titanic task. It is always argued in sporting circles that a real champion will perform well under any conditions. This sporting truism was exemplified when the issue of Trieste with the future of Zones A and B suddenly became featured in the Australian press. We had the famous Clare Boothe Lucre, U.S. Ambassador to Italy via her husband's ownership of *Time* Magazine trumpeting for Italy to have all.

With the U.S.S.R. annoyed with the non-aligned posture of Yugoslavia, it advocated for Trieste as a free part but said nothing about the rights of minorities in this region. It was to the eternal credit of a small band of Slovenes in Sydney and Melbourne that they embarked on

an effective form of political mission to stress the need for Slovenes in Zone B to be reunited with post-War Yugoslavia.

No rich propaganda machine existed to spell out this message of truth, simply their lucid exposition of historical events.

Gradually, letters in the press plus resolution at union meeting diluted this clamour that all of Trieste should revert to Italy. I well remember at A. L. P. Conferences in the mid-1950s, beachheads were established in Foreign Policy Reports to tie in rights of minorities with the Trieste issue. Yes, Zone B was saved, but regrettably the Austrian Peace of 1955 Treaty did not do justice to the Slovenes in the Carinthian region. But out of it all, names like Bizjak, Švigelj and Kavčič played a notable role to see the Australian press were aware of the attitude of the U. S. State Department in Trieste was not an infallible doctrine.

It should also not be forgotten that Melbourne had to suffer the patronising platitudes of Bartholomew Santamaria, Editor of *News-weekly* and now occasional correspondent to *The Australian* who said Slovenes never had it so good as when they were loyal obedient subjects of the Austrian-Hungarian Empire and that the Republic of Slovenia was a monstrosity.

Well, following external research with a Slovene group at the Chullora Railway Hostel, he received a very effective blast thanks to a solid Slovene mid-field team.

No one suggests this isolated action 14,000 miles from the area in dispute was the match winner, but rather an element of the Australian Community spoke up and its Government became aware that in such future issues it should listen and not accept U. S. or British Government evaluations.

Whilst the Trieste issue was a matter of external affairs, Slovenes played an equally important role in the crusade to have the 126 fatal casualties in the Snowy Mountains Hydro project properly remembered.

Just as Prime Minister Fisher thought nationally in his 1912-14 achievements, Prime Minister Chifley's vision in the 1948-9 era ensured that the Sunburnt Country that Dorrothea Mackellar's verses portray, had at least in New South Wales adequate water and power. The workforce that completed this mighty project comprised citizens of many nations, but out of all proportion to their numbers in Australia, Slovenes were well to the fore when at a vital stage of the construction, two vital tunnels successfully linked. Glowing tributes were paid to the workforce by the then Federal Minister for Development, David Fairbairn and his State Ministerial Counterpart, George Entincknap and assurances given that their deeds would be listed for posterity.

Well, the years rolled on and nothing happened so it was fitting that a former S. M. A. worker, Roman Bizjak born in Gorica mused like U. S. President John Fitzgerald Kennedy of men who dreamed of things that never were and asked why not.

In the early eighties, a small group were drinking at the Canberra Triglav Club when Prime Minister Fraser in a New Year's message stressed he was governing for all Australia, not only those who voted for him. Roman Bizjak turned to me and said why doesn't he build that bloody plaque for our old mates from the Snowy and a chorus of Amens echoed around the room.

The next morning, in conjunction with my supergirl secretary, Marion Grace, we laid the foundation for a national campaign. Initially, the Prime Minister brushed off my request, consequently his written rejection, together with petition lists were sent all around Australia, demanding the long overdue recognition come about. Ethnic Clubs, Trade Unions, Church groups, all were welded into a massed force clamouring for justice. Petitions delivered in the Commonwealth Senate were staggered in presentation to gain maximum projection. The ethnic press also played a notable roll, but the spearhead in this area and a longtime *Nova Doba* columnist and pioneer of the Sydney Triglav Club, Jože Čuješ played a mighty roll as area coordinator.

Ultimately, the plaque was built at Cooma and an official unveiling ceremony held, paid overdue tribute to those who gave their life on this national project.

Afterwards, those Slovene activists had their own gettogether, proud that their initiatives had succeeded.

Maybe Slovenes had been treated as second class citizens in the 1912 Western Australian era, but not now they had shown some of the traditions of the Eureka Stockade, blended with the Henry Lawson concept of mateship and had overcome all obstacles.

Without having the literary pretensions of a Louis Adamic, I have tried to show the quality of tenacity which Slovenes possess in abundance and which enabled them to deal with early adversity, be it in North America or Australia.

My first meeting with a Slovene occurred in the early Fifties, on a cold winter morning at the Chullora locomotive workshops. On the day before, combining the duties of union delegate and Picnic Day Committeeman, I had collected over two hundred pounds and found myself ten shillings short. A nuggety Slovene youth awaited me at my locker this morning and handed me ten shillings saying, 'you made a mistake with the change gave me yesterday'. In point of fact he had been exiled from

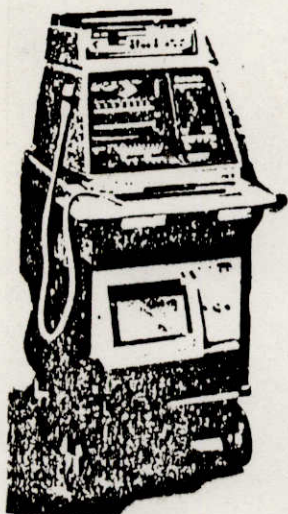
another workshop for being involved in an altercation with several Italian youths, when they got into an argument over Trieste. On reflection, the shop delegate might have played a much more positive role in Joe Bizjak's defence, but he didn't. The fact that this youth, despite the lack of union protection, was still concerned to remain financial showed that he saw his personal responsibilities in the broadest sense.

Subsequently, with Al Grassby's creation of the Immigration Advisory Council under my chairmanship, I was proud to have Joe Bizjak as a very valuable member.

Much more could be written in this vein, but I simply say that I never cease to admire Slovenes' pride of home ownership, often acquired as the result of some of the best years of their lives being spent in various hazardous underground mining operations.

When one is privileged to attend family gatherings in such venues with the traditional Slovene hospitality prevailing, one experiences the art of good living.

With the Australian society of the Eighties constantly menaced by the numerous perversions of the truth by the mass media, it needs the aid of its citizens of Slovene origin, with their objectivity and tenacious adherence to the concept of fairplay, to stabilise our political system.

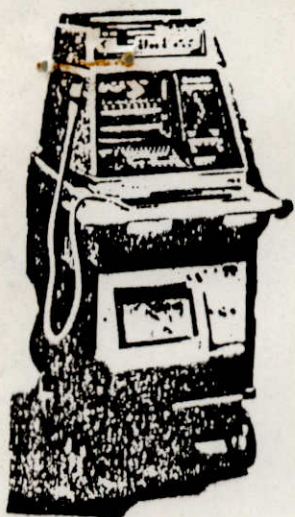

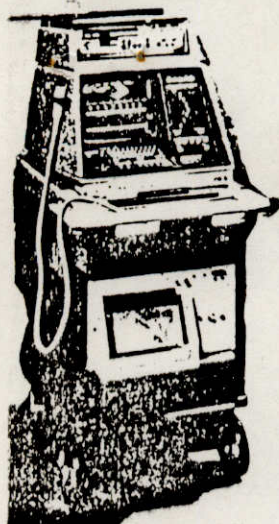

INCOME TAX : NATIONAL COMMITTEE TO RAISE FUNDS FOR MEDICAL

I refer to your letter of 28 October 1985 seeking income tax deductions for donations made to your organisation for the abovenamed purpose.

Your request falls for consideration under the Overseas Aid Gift Deduction Scheme. An organisation seeking recognition under that Scheme must, in the first instance, be approved for such purposes by the Minister for Foreign Affairs. Where an organisation has been so approved, gifts made to a public fund established by that organisation may qualify for deduction where the Treasurer is satisfied that the fund is established exclusively for the relief of persons in countries which have been certified by the Minister for Foreign Affairs as developing countries.

I have therefore arranged for your application, on behalf of HELP, to be referred to the Australian Development Assistance Bureau at the Department of Foreign Affairs for submission to the Minister for Foreign Affairs.

Should the application be approved by the Minister it would then be necessary to submit to this Office, for subsequent referral to the Treasurer, documentation establishing the abovementioned public fund. Such a fund should comply with the normal requirements which govern the eligibility of a public fund under the income tax gift provisions.

The requirements of such a fund are that:

- (a) the fund should be governed by a constitution or set of rules from which it is clear that its exclusive purpose is to provide relief to persons in certified developing countries;
- (b) members of the general public should be invited to contribute;
- (c) gifts to the fund should be kept separate from any other funds of the sponsoring organisation

(a separate bank account would be required) and clear accounting procedures evidencing this are necessary;

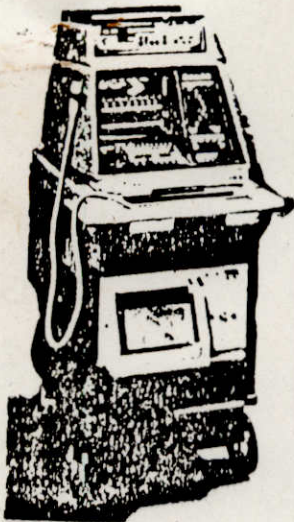
- (d) the fund should be public in the sense that it is administered by a committee of persons, a majority of whom have a degree of responsibility to the general community. In this respect it would be necessary to know details of the occupations and positions in the community of the fund's office-bearers;
- (e) consistent with the requirements at (a), the constitution or rules should provide that on the winding up of the fund any surplus money is to be transferred to some other fund qualifying under the overseas aid gift provision of the law, i.e. sub-paragraph 78(1)(a)(lxii) of the Income Tax Assessment Act 1936; and
- (f) the name of the fund should preferably reflect the fact that it is the developing countries aid fund of the organisation concerned, and gifts to the fund should be receipted in that name.

If the Treasurer is satisfied regarding the purpose for which the fund is established he may at his discretion declare the fund, by notice published in the Commonwealth Government Gazette, to be an eligible fund under the overseas aid gift deduction scheme. Generally, gifts to an eligible fund will be deductible from the date of the Gazette declaring its eligibility, although a later date may be specified for this purpose.

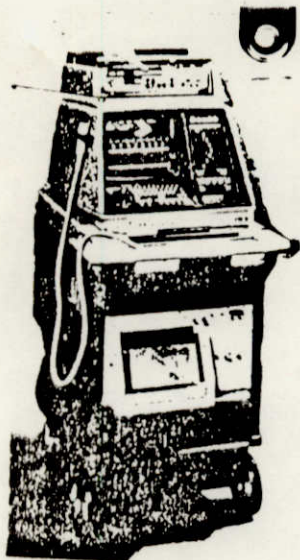
CRITERIA FOR TAX DEDUCTIBILITY

In September 1980, the Treasurer announced that tax deductibility for donations of \$2 or more would be granted to a number of Australian overseas aid organisations.

To be eligible to receive this concession an organisation must be a voluntary, not-for-profit non-government organisation, clearly identifiable as Australian, managed efficiently and able to provide evidence of its capacity to ensure competent implementation of the overseas projects it undertakes or supports.

Consideration may also be given to the status and financial viability of the organisation, the extent to which the organisation is able to mobilise community support for its overseas aid activities, the capacity of the organisation to contribute to overseas development assistance, its past record in providing aid to developing countries and its effective links with counterpart organisations overseas.

To continue to be eligible to receive assistance an organisation must submit annually a copy of its audited financial statements and annual reports. Organisations should also update the information on their Organisation Profile whenever significant changes occur.


I note that your organisation is registered under the Charitable Collections Act by virtue of its Certificate of Registration No. CC 26527.

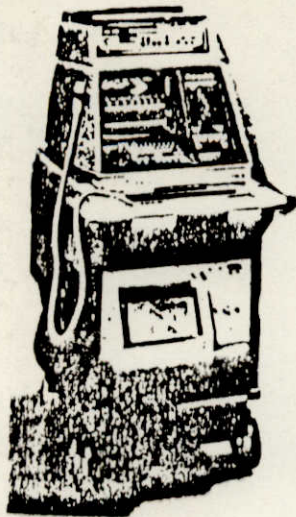
