Re: Legionnaires' Disease.

You would be aware of the recent publicity and public concern regarding the illness and death of Fairfield residents who have contracted Legionnaires' Disease.

The most common form of transmission for this disease is through dirty and poorly serviced air conditioning systems, which have water cooling towers.

An Australian Standard aimed at minimising the risk of an outbreak of Legionnaires' Disease has recently been published. The Standard details minimum requirements for operation and maintenance of vulnerable plant and equipment such as air handling systems or refrigeration equipment using water cooling towers.

Council is anxious to maintain the best possible standard of public health safety and is conducting a survey to update its information regarding premises having the type of equipment listed above.

Information collected will enable Council to:-

- Minimise the risk of an outbreak, or
- Investigate and control any outbreak quickly, and/or
- * Eliminate speculation and publicity regarding premises associated with any outbreak.




